

BEGINNING AT THE SOUTHWEST CORNER OF SAID SECTION 24; THENCE, ON THE SOUTH LINE OF SAID SECTION, S88°38'39"E FOR A DISTANCE OF 658.98 FEET; THENCE, PARALLEL WITH THE WEST LINE OF SAID SECTION, N01°38'11"E TO A POINT OF INTERSECTION WITH THE NORTH LINE OF SAID SOUTHWEST QUARTER, BEING A DISTANCE OF 2643.52 FEET; THENCE, ON SAID NORTH LINE, N88°32'39"W TO THE NORTHWEST CORNER OF SAID SOUTHWEST QUARTER, BEING A DISTANCE OF 658.98 FEET; THENCE, ON THE WEST LINE OF SAID SOUTHWEST QUARTER, S01°38'11"W FOR A DISTANCE OF 2644.67 FEET TO THE POINT OF BEGINNING, CONTAINING AN AREA OF 40.00 ACRES, MORE OR LESS.
